Driving Directions:

From North:

Take Rte. I-93 South or Rte. 128 South to Rte. 3 South towards the Sagamore Bridge. Take Exit 6A Rte. 44 East. As you exit the ramp you will be traveling in an easterly direction on Rte. 44. Follow Rte 44 East for approximately 1 mile. You will come to the intersection with Rte 3A (also known as Court Street) there will be a set of traffic lights with Belsito Real Estate on your right hand side and a Mobile Gas Station diagonally across from you. Travel straight through that traffic light. After approximately ¼ of a mile you will encounter a small rotary directly in front of Plymouth Harbor. Take a right at that rotary. This is Water Street; you will follow Water Street for approximately 1 mile past the Mayflower Ship on your left and Plymouth Rock (housed by large granite columns) on your left. Shortly after Plymouth Rock take a right hand turn on Leyden Street. At the top of Leyden Street there is a traffic light. Take a right at the traffic light onto Main Street. The Winslow-Warren Building (a brown two story wooden building) #65 is approximately 1 ½ blocks down on your right hand side. There is a Harold F. Moody, Jr., Attorney at Law sign on the building. If you do not find parking on Main Street take a right hand turn immediately after the Winslow-Warren Building onto North Street, there is additional street parking on North Street or down approximately 1/8 of a mile there is a municipal (town) parking lot on the left hand side directly opposite the Plymouth Art Guild.

From the South:

Take Rte.3 North to Exit 5 (Long Pond Road/Plymouth Center). At the end of the ramp take a right. Follow for approximately 1 ½ miles to an intersection with Sandwich Street. There will be a stop sign at which you cannot go straight. There will be a Texaco Gas Station directly across from you. Take a left onto Sandwich Street. Continue straight on Sandwich Street past Friendly's on your left. You will pass a Post Office Building on your right. Go straight through the traffic lights at the Post Office Building. Once you go through this set of traffic lights this is now Main Street. The Winslow-Warren Building, #65 Main Street is approximately two blocks up on the right hand side at the corner of North Street. It is a two-story brown wooden shingled building. There is a Harold F. Moody, Jr., Attorney at Law sign on the building. If you do not find parking on Main Street take a right hand turn immediately after the Winslow-Warren Building onto North Street. There is additional street parking on North Street or down approximately 1/8 of a mile there is a municipal (town) parking lot on the left hand side directly opposite the Plymouth Art Guild.

From the West:

Take Route 195 East to Route 495 North. Off of Route 495 North take Exit 6 (Route 44 East) towards Plymouth. Follow Route 44 East for approximately 15 miles. At the end of Route 44 East merge onto Route 3 South (there is good signage). Take the first exit (Exit 6A) Rte. 44 East. As you exit the ramp you will be traveling in an easterly direction on Rte. 44. Follow Rte 44 East for approximately 1 mile. You will come to the intersection with Rte 3A (also known as Court Street) there will be a set of traffic lights with Belsito Real Estate on your right hand side and a Mobile Gas Station diagonally across from you. Travel straight through that traffic light. After approximately ¼ of a mile you will encounter a small rotary directly in front of Plymouth Harbor. Take a right at that rotary. This is Water Street; you will follow Water Street for approximately 1 mile past the Mayflower Ship on your left and Plymouth Rock (housed by large granite columns) on your left. Shortly after Plymouth Rock take a right hand turn on Leyden Street. At the top of Leyden Street there is a traffic light. Take a right at the traffic light onto Main Street.
